The opening and closing of the ski season, the daily opening and closing times of the lifts, as well as the partial or full daily opening of the lifts is purely indicative. The opening of the ski season may be postponed or its closure brought forward in the entire District or in certain areas, due to snow cover, weather conditions or other reasons which prevent proper enjoyment by users or due to measures taken by the Public Authority. The closure of lifts and slopes, the reduction of daily opening hours or the reduction of lift capacity may be ordered during the season for technical reasons (breakdowns or the need for extraordinary maintenance work), for safety reasons or for weather-related reasons (e.g. wind above permissible limits, poor visibility, unsuitable snow or snowpack conditions, danger of avalanches that may affect slopes open to the public or the route of one or more lifts, or even just to prevent skiers from accessing areas that have become dangerous, etc.), for electrical blackouts, for the closure of one or more access roads to the ski area, for strikes (including those by Sestrieres staff) and, more generally, for all reasons beyond the control of Sestrieres. We would like to inform you that the snowmaking service in the areas of Sauzes d'Oulx, Sansicario and Cesana Claviere is the responsibility of the Unione Montana Comuni Olimpici Via Lattea; moreover, a limited number of slopes within the District will be dedicated exclusively to the training of local ski clubs, and competitions that are promotional, commercial or sponsored by Italian federation through the ski clubs may be organized occasionally on certain other slopes. The opening schedule may also be conditioned by bans, limitations and restrictions on the mobility of persons for the use of the lifts imposed by the Public Authorities for reasons relating to the international geopolitical situation or energy conservation, as well as other reasons that make them necessary or appropriate. There is a ski pass which expressly offers the opportunity to also use the ski lifts and ski slopes of the ski resort of Montgenèvre which are located in France and are managed by Regie des Remontees Mecaniques del Montgenèvre, the organization responsible for the custody, maintenance and safety of the slopes, the operation of the lifts, rescue and the management of accidents. The user must therefore comply with the regulatory provisions regarding the use of the ski lifts and ski slopes in force in France, and those specifically imposed by the operator. Moreover, the user acknowledges and accepts that Sestrieres has no responsibility for any impossibility to use the ski lifts and ski slopes of the Montgenèvre resort, for the existence of limitations to their use or for damages suffered during their use or while visiting them. Consequently, the user acknowledges and accepts that they shall not be entitled to any reimbursement, compensation or indemnity for any cause, title or reason whatsoever from Sestrieres, in the hypothetical situations contemplated above or for any other event occurring on the slopes and facilities of the Montgenèvre ski resort and in the facilities and areas related to them. Based on the above, users must check the daily opening schedule on the website www.vialattea.it, or the "Bollettino Vialattea" on the Vialattea Ski App and the notices regarding the opening of lifts and ski slopes displayed at the ticket offices. With reference to the opening and closing of the lifts, the skier must still comply with the provisions of the "Contractual Conditions of Sale of Ski Passes and Regulations for the Use of Lifts and Slopes".
